

Call for Events under the label of the European Choral Association in 2025

These can be events for choirs, singers, conductors, composers, or managers, with differing and flexible structures and programmes. The artistic programme will be approved by the European Choral Association's Artistic Strategy Group, and the organisers can ask for proposals and ideas.

PRINCIPLES:

These events should be:

- NON COMPETITIVE
- EDUCATIONAL ASPECT
- INTERNATIONAL

GET:

- promotion on different channels of the European Choral Association
 - Brochure of events*: S+M-events: 1-page advert and L-events: 2-page advert
 - Mention on newsletter and on social media
- input for musical programme
- long-time experience and renowned expertise
- increase in international visibility

* The Brochure of events 2025 will be published in summer 2024, distributed physically to choral events and published online on our channels.

CONDITIONS:

- implement your own event linked to the European Choral Association rules:
 - approved musical programme;
 - invite one of our representatives to the event;
 - supply data, photos and evaluation.
- The participation fees must be based on the European Choral Association's system with reduced fees for indirect members (members of a member organization of the European Choral Association and members of the Friends of the European Choral Association) as well as different fees for participants from different countries (country group system – the exact difference may be discussed case by case and handled in a flexible way).
- The organisers of these events must use the logo of the Association in connection with the sentence "Event under the label of the European Choral Association".
- Pay the communication fee according to the table below.

Communication Fee

Events under the label of the European Choral Association have to pay a communication fee in exchange of communication services provided by the European Choral Association, based on the size of the event, as described below.

Communication fee:

- flat fee (non-refundable) to be paid in advance before the event + fee per international participant (i.e., coming from a different country than the one hosting the event) to be paid after the event (with the exception of S events, see below).

For this kind of events, the communication fee will be calculated as follows:
