Events under the label of the European Choral Association in 2026

Apply for your event to be promoted as an event under the label of the European Choral Association if you would be interested to:

- **Connect** your event to the European Choral Association - the voice for collective singing in Europe and beyond - and its values
- **Reach out** to its large network
- **Increase** your events' international visibility

These are **events for choirs and singers, vocal leaders / conductors, creators / composers, educators/ teachers and/or choral lovers**, with differing and flexible structure and programmes.

The **artistic programme** will be **approved** by the European Choral Association's Artistic Strategy Group, and the organisers can ask for proposals and ideas.

PRINCIPLES - the events must

- Be NON COMPETITIVE
- Have an EDUCATIONAL ASPECT
- Be INTERNATIONAL with information available in English

What you will GET:

- An increased visibility in the network of the European Choral Association and beyond
- Profiting from being associated with the European Choral association and its values
- Promotion of your event in different channels of the European Choral Association
 - Dedicated space in the digital brochure of choral events
 - Event listed on Calendar flyer 2026
 - Possibility to display printed material at our Membership Weekend
 - promotion in newsletter and on social media
 - At least one mention in our newsletter
 - At least one dedicated post on our Facebook and Instagram accounts
- Input for musical programme (if you wish so)
- Advice from our team with long-time experience and renowned expertise (if needed)

CONDITIONS:

- You must implement your event according to the European Choral Association's rules:
 - Approval of musical programme by the association's artistic strategy group;
 - Invitation of one representative of the Association to the event;

- Supplying data, photos and evaluation after the event
- The participation fees of the event must be based on the European Choral Association's system with reduced fees for indirect members (members of a member organization of the European Choral Association and members of the Friends of the European Choral Association) as well as different fees for participants from different countries (country group system – the exact difference may be discussed case by case and handled in a flexible way).
- You must use of the logo of the Association in in connection with the sentence "Event under the label of the European Choral Association" in all communication about the event
- You have to pay a Label fee in exchange for the services offered, according to the table below

Label Fee

Events under the label of the European Choral Association have to pay a fee in exchange for services provided by the European Choral Association, based on the size of the event, as described below.

The Label fee consists of a non-refundable flat fee to be paid in advance before the event. For this kind of events, the communication fee will be calculated as follows:
